## **ARC RULES TO FOLLOW**

- 1. Any changes to the exterior of the house requires a ARC form to be filed prior to the commencement of your project.
- 2. All construction, other than roofs, require a survey form (Plat) with the location of the work drawn on it. This includes Landscaping changes.
- 3. When replacing roof shingles, you need to supply the name and type of shingle being used, as well as the color. We also request that you put the name of the installing company on the form.
- 4. If the changes involves major construction, i.e., Sun-rooms, Pergola's and Sheds, architectural/engineering drawings must be supplied. Hand drawings will not be accepted. Permit approval must be submitted if required by The Town of Mooresville or Iredell County.
- 5. The ARC Committee has 30 days to make a decision. If you have not heard from the committee in that time, you must re-submit and there is a 10 day wait period. If there are questions from the committee, the 30 day clock starts when the answers are received. If both time periods expire and you have not heard from the committee, then you can proceed. Be aware, you will need to prove that you submitted.
